# **Search Descriptions**

#### International Criminal Records Search

**Description:** If an applicant has lived abroad, or currently lives abroad, Ministries may request an International Criminal Records Search. The International Criminal Records Search searches available jurisdictions in the applicable country in which the applicant has resided or currently resides. The scope of records reported varies by country. This search is limited to the country ordered, and will not return records within the United States unless a search within the U.S. is ordered.

## International Illicit Activity Database Search

**Description:** This search is based on a criminal database that may include government sources, proprietary databases, and various other organizations that track criminal history information. It is designed to reveal any illicit activities or affiliations related to the applicant that may not be visible through standard criminal record checks. The purpose is to provide a more comprehensive understanding of an individual's background, especially in regions where official records might be limited or hard to access. The range of records reported can vary by country. This search is restricted to the specified country ordered and will not return records from the United States.

## Negative Media International Search

**Description:** An International Criminal Records Search is not available in every country. If a country does not provide an International Criminal Records Search, a Negative Media Search may be conducted through private databases, public sanctions lists, media sources, and other public and private record repositories. The scope of records reported varies by country. This search is limited to the country ordered, and will not return records within the United States unless a search within the U.S. is ordered.

## International Certificate Validation

**Description:** This search serves to validate the applicant's Criminal Certificate, a document often mandated in many countries for individuals seeking employment in childcare or healthcare sectors. In certain jurisdictions, the validation process includes confirmation of the certificate with the issuing authorities. It is important to note that this service requires the applicant to obtain and, if necessary, bear the cost of their Criminal Certificate. The scope of records reported varies by country. This search is limited to the country ordered, and will not return records within the United States unless a search within the U.S. is ordered.
